National Insurance

The chancellor is cutting the main rate of national insurance contributions (NICS) paid by employees from 12% to 10% with effect from 6 January 2023.

The chancellor also announced changes to the national insurance paid by those who work for themselves. From 6th April 2024, self-employed workers will no longer have to pay class 2 NICS (currently £3.45 a week and are paid by registered self-employed workers with profits of £12,570 or more a year). Also, class 4 Nics of 9% paid by the same self-employed worker will be reduced to 8% from 6th April 2024.

Tax Investigations on the rise

Back at the end of July 2023, HMRC released their annual report, which covered certain areas such as tax revenue, decrease in tax gaps and accurate tax payments. They wish to invest into compliance officers in an effort to tackle fraud due to the COVID crisis. Therefore, they are wishing to increase its number of tax investigations.

They managed to collect an impressive £814 billion in tax revenues last year, out of which £34 billion was the result of their efforts in curbing avoidance, evasion, and non-compliance.

HMRC has a compliance strategy consisting of three key elements

- Preventing non-compliance,
- Promoting good compliance,
- Responding firmly to those who violate the rules.

Limited vs Sole Trader vs Partnership



In the past, being a Limited company was always seen to be the most tax efficient way for many clients to run their businesses.

However, following recent tax changes over the last few years, including

- Introduction of a dividend tax
- Increase in corporation tax rates for profits over £50000
- Cut in Class 4 National Insurance

All of these measures combined mean that for many clients, being Ltd is no longer as tax efficient as it previously was, and there may be more tax efficient ways to structure your business.

HMRC Phone Lines

HMRC plans to reduce phone line access by 30%

How many times have you dreaded having to call HMRC, wondering how long it will take to speak to an advisor? Well unfortunately it's only going to get worse.

Under new plans, HMRC will reduce access to its call centres and helpline advisers at its contact centres by 30% by December 2024 as it struggles to cope with increasing demand and cuts to staffing budgets.HMRC hopes this will also force people to move to digital services by default, believing that moving help and advice online will help it deal with questions more effectively. HMRC say almost any task that can be actioned, or query that can be resolved on the phone, can also be sorted via webchat. Setting up a personal tax account also allows you to check and manage HMRC records, including income tax, change of address, self-assessment and company car tax.





Increase in Minimum Wage

The Government has announced its acceptance of the Low Pay Commission's recommendations on minimum wage rates to apply from 1st April 2024. The rates recommended by the LPC are set out below:

National Living Wage -£11.44 18-20 Year Old Rate -£8.60 16-17 Year Old Rate £6.40 Apprentice Rate £6.40

Fully Expensing

It has been announced in the chancellor's spring budget that full expensing is to be extended to 31st March 2026. Full expensing allows a company to claim 100% first year relief on qualifying new main rate plant and machinery investments in the year of purchase, instead of spreading the relief over numerous years, claiming either 18% or 6% relief per year.

The full expensing scheme has been in place since 01st April 2023, and replaces the slightly more generous super deduction scheme, which ended 31st March 2023.
